1. Full payment, in **Canadian dollars (\$CAD) only**, must accompany entry form to be registered in the match. Payment made by credit card will necessitate the addition of a 3% cost recovery charge. Wire transfers and electronic money transfers are also accepted.
2. DCRA membership is compulsory for all participants.
3. **Entries received by the DCRA prior to 1 June 2019 are subject to a discounted entry fee (see below).**
4. Your PAL or Non-Resident Firearms Declaration must always be available for scrutiny.
5. The Black Powder Program Booklet will be included with each competitor package to be picked up during registration.
6. Entry fees will only be refunded in exceptional circumstances. Refunded entries will incur a 15% booking fee.
